TECHNICAL EVALUATION CRITERIA REGARDING SEASONAL RESIDENTIAL PARKING PERMITS NEAR PARKS, BEACHES OR OPEN WATER ACCESS POINTS This Ordinance adds a new Subsection I to Chapter 231, Article III, Residential Parking Permit Program, Sec. 231-36. Technical Evaluation Criteria of the Code of Ordinances to permit the waiver for seasonal residential parking permits of Subsection H(1), which requires denial of a residential parking permit petition if a parking occupancy study conducted during the peak parking period finds that on-street parking utilization is less than 75% percent, if the petition to establish a residential parking permit area is within one third (1/3) of a mile of a Park, Beach or Open Water Access Point that is deemed a major traffic destination by the Director of Operations or their designee. SUMMARY OF PROPOSED ORDINANCE NUMBER **SUPPLEMENTAL** AMENDING CHAPTER 231, VEHICLES AND TRAFFIC, SECTION 6, PROHIBITED STOPPING, STANDING OR PARKING, This ordinance amends Chapter 231, Vehicles and Traffic, Section 6, Prohibited Stopping, Standing or Parking, of the Code of Ordinances to 1) make parking within twenty-five (25) feet of a crosswalk or at any place where official signs prohibit stopping or parking Class III parking violations; and 2) make parking in violation of residential parking permit area regulations a Class IV parking violation . SUMMARY OF PROPOSED ORDINANCE NO. ____SUPPLEMENTAL AMENDING CHAPTER 231, VEHICLES AND TRAFFIC, ARTICLE III, RESIDENTIAL PARKING PERMIT PROGRAM, SECTION 44, VIOLATIONS AND PENALTIES This ordinance amends Chapter 231, Vehicles and Traffic, Section 44, Violations and Penalties, of the Code of Ordinances to delete Subsection G, which makes it a violation of the Article III to park in a residential parking permit area without a valid permit and increases the fine for a violation of Subsections B, C, D or E to \$120.
