RESOLUTION NO. 4404 AUTHORIZING MAYOR CAROLINE SIMMONS TO ACCEPT A GIFT OF ADVERTISING SPACE IN THE STAMFORD TRANSPORTATION CENTER FROM CHARTER COMMUNICATIONS

WHEREAS, Section C2-10-2 of the Charter authorizes the Board of Representatives to accept gifts on behalf of the City; and

WHEREAS, Charter Communications has contracted with Inspiria Outdoor Advertising of White Plains, New York to lease certain advertising space in the Stamford Transportation Center; and

WHEREAS, Charter Communications wishes to donate to the City such advertising which Charter Communications is unable to use in a timely manner; and

WHEREAS, the Director of Economic Development wishes to use such advertising space to post advertisements which will advance the interests of the City; and

WHEREAS, the value of such advertising space is approximately Two Hundred Seventy Thousand Dollars (\$270,000.00); and

WHEREAS, it is desirable and in the public interest for the City of Stamford to accept said donation and to advertise in the Stamford Transportation Center for the purpose of advancing the interests of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF STAMFORD BOARD OF REPRESENTATIVES:

- 1. That the donation by Charter Communications of advertising space in the Stamford Transportation Center is accepted.
- 2. That Mayor Caroline Simmons is authorized to and execute and file all documents and agreements between the City, Charter Communications and Inspiria Outdoor Advertising which shall enable the City to make use of advertising space in the Stamford Transportation Center.
- 3. That the advertising which the City shall post in the Stamford Transportation Center shall be directed at advancing the interests of the City.

BE IT FURTHER RESOLVED that this Resolution shall become effective upon passage.
