Rep. Di Costanzo made a motion to keep Sec. 231-7 Parking violations Section A (1) at Twenty (\$20.00). Motion was seconded and approved by 7-0-0. (Reps. Deluca, Adams, Franzetti, Di Costanzo, Giordano, Moore, and Pratt in favor)

Rep. Franzetti made a motion to amend Sec. 231-7 Parking violations Section A (3) Class III from sixty (\$60) to seventy (\$70). Motion was seconded and approved by a vote of 6-1-0. (Reps. Deluca, Adams, Franzetti, Giordano, Moore, and Pratt in favor; Di Costanzo opposed)

Rep. Franzetti made a motion to amend Sec. 231-7 Parking violations penalties Section A (4) Class IV parking regulation, except that parking in a handicapped space, from ninety five (\$95) to one hundred (\$100). Motion was seconded and approved by a vote of 6-1-0. (Reps. Deluca, Adams, Franzetti, Giordano, Moore, and Pratt in favor; Di Costanzo opposed)

A motion to approve this item as amended was made, seconded and approved by a unanimous vote of 7-0-0. (Reps. Deluca, Adams, Franzetti, Di Costanzo, Giordano, Moore, and Pratt in favor)
