Mr. Bittenwieser, said that through a vigorous and competitive process, The Street Plans Collaborative was selected for the Stamford Vision Zero Action Plan. The Action Plan is the guiding document for the City to come up with various policies, programs and projects to achieve the goal of zero roadway deaths and serious injuries.

Mr. Petise stated that this is part of study that was done many years ago. This project has been around for 20 years to ease traffic congestion and provide better pedestrian and bicycle infrastructure for multiple intersections. The idea is to create a one-way circulator so that Greenwich Avenue is one-way southbound and Davenport Street is one-way North Bound. This will ease congestion at Greenwich, Selleck and Southfield to have one way from the North coming into that intersection.
