PUBLIC NOTICE

CITY OF STAMFORD DESIGNATION OF ALTERNATE SIDE PARKING STREETS DURING SNOW ACCUMULATION CODE OF ORDINANCES 231 – 55-58

The Office of Operations of the City of Stamford is hereby designating alternate side parking streets during snow accumulation of greater than two inches.

On the streets designated below, alternate side parking rules will automatically take effect each time there is snow accumulation greater than two (2) inches. The alternate side parking will take effect regardless of whether a snow emergency has been declared. The purpose of these rules is to facilitate snow removal by providing adequate maneuvering space for snow removal equipment on narrow roadways.

When in effect, parking will be allowed on the even house/building number side of the street and restricted on the odd house/building number side on even numbered calendar dates from 8am until 8am the following day. On odd numbered calendar days, parking will only be allowed on the odd house/building number side of the street and restricted on the even house/building number side of the street from 8am until 8am the following day.
