<u>Call to Order</u> Chairman Jon Gallup began the meeting at 3:29 p.m.

The funding request is made for the City of Stamford, Transportation Engineering Department for Stamford Street Smart Initiative. Mr. Rosenberg review the City Charter and City Code and there are no restrictions upon transfers of funds from the Transit District to a City Department specifically for bus shelter advertisement.

Robert Figueroa made a motion approve the funding request for City of Stamford, Transportation Dept., Stamford Street Smart Initiative, in the amount of \$4,200.00.
