Dear Representative Cottrell,

The new zoning text limiting smoke shops (including signage) went into effect on July 25. Every Smoke Shop that was legally in existence or had a complete application in by that date needs to be treated according to the old regulations, based on the State Statute which permits legally existing uses to remain (grandfathering).

For your reference, here is the approved text https://www.stamfordct.gov/home/showpublisheddocument/28956/638239713510770000 (pp 6 and 7 of the document)

The Land Use Bureau no longer enforces the Zoning Regulations. This function was moved to the Building Department. You should contact them to investigate if the Smoke Shops you are referencing have the proper permits and or are grandfathered in.

Because of the grandfathering requirement, Zoning can not require smoke shops to comply with the new regulations if a use was legally in existence (or had filed for an application) before the effective date.

The BoR may be able to pass an ordinance that requires Smoke Shops to become compliant with the new sign regulations. However, this is a question that should be reviewed by the Law Department - State Statute might limit the ability of the BoR to do so.

I hope that answers your questions.
