RE: Authorization and Certification for Critical Emergency Purchase – playground repair and drainage work at thirteen City schools

Please accept this memorandum as my certification that the abovementioned project meets the definition of a Critical Emergency Purchase under Stamford City Code Section 23-18.3.

Additionally, I am requesting your written consent to waive the competitive bid process in the procurement of the necessary playground repairs, in accordance with Section 23-18.3 of the City Code. Due to the numerous Class A Hazards defined as *Any condition of the playground that is life threatening or could cause severe, permanent disability,* failure to complete this work would require the closure of the playgrounds. In addition to the playground repairs, the work will address chronic drainage issues which have exacerbated the mold situation at a number of schools.

With your concurrence, the work will be completed by Viking Construction, Inc. at a cost not to exceed \$435,152.21. Viking Construction, Inc. is uniquely positioned to provide the most cost effective service. Viking is familiar with the various locations, and in many instances is on-site, thereby reducing mobilization costs.
