## 19TH BOARD OF REPRESENTATIVES

## STAMFORD, CONNECTICUT

A regular monthly meeting of the 19th Board of Representatives of the City of Stamford was held on Monday, November 9, 1987, in the Legislative Chambers of the Board in the Government Center, 888 Washington Boulevard, Stamford, Connecticut.

Prior to the start of the regular Board meeting which was the last meeting of the 19th Board, a Recognition Dinner was held. Sanchia Spandow, from the Governor's office was to speak but was called to another meeting. Speaking on behalf of Ms. Spandow was Representative Ruth Powers. Rep. Powers read a tribute from Governor William O'Neill for the outstanding service contributed to the city from the members of the Board of Representatives that will not be returning to the 20th Board. The members are Jeanne-Lois Santy, Barbara McInerney, Sal Signore, William Heins, Terrence Martin, James Dudley, Jr., James Tooher, Rosanne Begel, W. Dennis White, and Claire Fishman.

President Goldstein thanked Reps. Thomas Burke and Ruth Powers for all the work they did preparing for the evening's activities.

President Goldstein stated that after this evening's meeting is adjourned, the 19th Board will be history. She said the 19th Board has been an extraordinary, very dedicated, conscientious Board and the Representatives were very giving. She said that some Representatives will not be returning to the Board; some chose not to run for re-election. She said that the Representatives work together from different sides of the aisle, but after the meeting is over, after the agreements and disagreements, each one respects the other as a conscientious, dedicated public servant. She said that no one realizes, only the people serving on the Board, the kind of work, and the obligations and pressures that go into being on the Board.

President Goldstein said that some of the people leaving the Board have served on the Board for various lengths of time. She called on the ones first who have served the fewest number of years.

President Goldstein called William Heins to the podium. She said that Will has served his district, the 13th District admirably. He has been an excellent member of the Committees that he chose to serve on. He has honored his party and the city. President Goldstein presented Will with a plague for his service on the Board. Will will be missed by all.

The next person called was Rep. Rosanne Begel. President Goldstein said she is a friend and will be missed on the 20th Board. Rep. Begel made her mark not only with her constituents in the 14th District and is known as the person who cares about affordable housing for the whole city and has made it her project to fight for. Roseanne was presented with a plague for her service on the Board.

She said that Sal represented the 18th District. Sal held Leadership positions on the Board, and Sal has stood out amongst his peers. His name in the city is truly one to covet and honor. Mr. Signore will be missed and has been a credit to the Board. A plague was presented to Mr. Signore.

President Goldstein said the next two people who have chosen not to run again are two leaders of the Republican Party who have made their mark on this Board and the city in a way that is remarkable; Jeanne-Lois Santy who has served for 12 years. President Goldstein said that Lois has the respect of all members. Lois has exhibited leadership and dedication to the principles in which she believed in. She will be missed on the 20th Board. President Goldstein presented Lois with a plague and wished her the best in the years ahead.

President Goldstein called on Barbara McInerney. She said that Barbara is a friend and an opponent. A Board without Barbara is hard to contemplate. Barbara will be missed by the Board, her constituents and the City. She was presented with a plague.

The Board was like a family to her. She said that six years ago when her granddaughter was born all shared the joy and two years ago when her grandson was born there was madness and pain. She said she appreciated the prayers and John Boccuzzi asking her how her granson is and John Zelinski calling and Millie Perillo calling. She did not want to slight anyone; but all were concerned and she appreciated that. Mrs. Santy said the friendship of the Board will be among her many blessings and loved all. She thanked all the members.

Mr. Heins thanked President Goldstein, Tom Burke and Ruth Powers for putting this memorable evening together. He said that this has given all of those leaving a very warm feeling. He said the two years on the Board were a great experience. He said that Stamford has a great variety of people all sitting together who make things work in the City of Stamford which has much diversity. Mr. Heins was glad to have had the opportunity to be a part of all of it. He thanked everyone.

Mr. Dudley said that six years ago when he came on the Board, he had a daughter. When he ran for re-election, he had another daughter, but now that he is going out, he is going with a son. He thanked Rep. Summerville for all she did over the past six years. He thanked everyone. He said that all worked as a team. The people in his district, the 6th have been great to him and Rep. Summerville. Some things were accomplished and some were not. He said that though he would not be on the Board, he would be fighting. He thanked all the Board members and the people in the district.

Mr. Terrence Martin said that he had much to say but would not. He thanked all for the enjoyable experience and for the many happy memories. He said he did not know when he would return to the Board. Perhaps, when Nick Pavia decides to retire from politics making the 10th District safe for democrats again. He expressed his admiration to the Board's Leadership especially, President Sandra Goldstein. Planning and zoning has always been a concern to Mr. Martin and the Board will. probably be hearing about any of these matters from Mr. Martin in the near future.

Mr. W. Dennis White thanked all for the pleasure of the company. He said were it not for this Board, Stamford would have gone down the drain long ago. He said that this Board represented neighborhoods and wanted that to be kept in mind. Again, he expressed his thanks.

## MOMENTS OF SILENCE:

By Rep. W. Dennis White: "Tonight is the 49th anniversary of Christalnacht which was the official beginning of the Holocaust. That night, 55 thousand Jewish leaders in Germany were taken and sent to death camps. None of them were ever heard of again; the academic, the intellectual, the political leadership of the German-Jewish community and every single synagogue, Jewish Center and shul was destoyed that night and at one fell swoop over a thousand years of Jewish life ended in Germany and this was the official beginning of the Holocaust and this ought to be noted, Madam President."

By Rep. Annie M. Summerville: "For the late Margot H. Wormser who died October 14, 1987. Mrs. Wormser survivors include her husband Eric, and two sons, Peter and Thomas. She was the Deputy Director for the Housing Authority for many years. For those who knew her, knew her as a fighter. She fought until the end. Mrs. Wormser fought for affordable housing in the city. She did not only talk about it; she tried to do as much as she could for it. She will be missed by her family and all her friends."

By Rep. Annie M. Summerville: "For the late Milton Turkel who died October 27, 1987. I remember Attorney Turkel when I came to Stamford as a fighter for human rights. I remember him vividly down on West Main Street which is now the Shelter for the Homeless and one would be amazed to see such a gentleman of his character fighting and standing when it was not popular to say the things he was saying in the NAACP. He stood with us on many occasions when there were unpopular issues. The NAACP will never be the same in this city. After he retired from many activities, he counseled us on many issues. We will miss him dearly."

Mrs. Fishman: "For Arthur Post. I was privileged to have him live in my district and to know him. My condolences go to his wife Beulah and his daughter Ellen Camhi and the rest of his family."

By Rep. James Dudley: "For the veterans and servicemen who served their country."

By Rep. Audrey Maihock: "To honor the memory of Margot Wormser. A public servant who worked to the very end of her life; dedicated to the best interest of this city."

By Rep. David Blum: "For a constituent in my district, Mr. Milton Turkel. He fought against discrimination. Milton Turkel was a magistrate in the court and former legal counsel for the Stamford NAACP. He died after a brief illness. He was born in New York City on September 28, 1907. He graduated from Columbia College and Columbia University Law School. Mr. Turkel had been an attorney for over 40 years and most recently served as magistrate of the court for the state. The magistrate's position was created in recent years to allow the experienced attorney to assist judges handling minor matters. Mr. Turkel for 30 years was a member of the NAACP. He served as President of the organization from 1966 to 1970. In 1978, he was honored for his long years of service. In Stamford, he fought discrimination and was an early supporter of zoning that would affect the desegration of schools in Stamford. As the legal counsel for NAACP, he helped make possible minority representation on the Urban Redevelopment Commission. A Moment of Silence for a great man, Mr. Turkel."

By Rep. Scott Morris: "I, too, would like to join Ms. Summerville and Mrs. Maihock in asking for a Moment of Silence for Margot Wormser, a truly remarkable lady who I was privileged to know for most of my life as a neighbor both in the Newfield area and North Stamford and whose sons I grew up with. She just left her mark on the city, an indelible mark, and I can't imagine what it is going to be like without her. She will be sorely missed."

By Rep. Lathon Wider: "I would like to talk about a man who has walked with me in many dangerous seen and unseen situations in this City of Stamford. Some can talk about Attorney Turkel but very few knew him for what he was. He was zealous and walked in danger on many occasions that he did not know about. I will miss him because I had run into questionable problems concerning the law in this city and I went to him for advice. He was part of the reason that I am sitting on the Board. I was one of his products. I really loved him like a father. I cannot say enough about him."

By Rep. Lathon Wider: "Mrs. Wormser was a woman that I have worked with for 30 years. She was the first Chairman of the Fair Housing Committee in this City. We worked together and did a fantastic job. Later, she went with the Housing Authority. Mrs. Wormser was responsible for 11 North Street being there. This project was held up for four years because of Environmental Protection. The seniors that live there are proud of where they are living, and the credit goes to Margot Wormser because she was a dynamic leader that put that together."

By Rep. Lathon Wider: "For the late Joseph Davis. He worked for Eastman Motors for over 30 years. We walked together many times to get membership for the NAACP."

By Rep. Jeremiah Livingston: "For the late Margot Wormser and Milton Turkel. I echo everything that has been said in her behalf. She was a dynamic person. I join Mr. Wider when he says his sitting on this Board is through the efforts of Mr. Turkel. I was in jeopardy some years ago on whether I was staying on this Board; I was viciously attacked on the streets and a man such as Mr. Turkel stood before the judge and pleaded my case. I was one happy person when the judge said for me to go home and that I had no business being before him in the first place. Mr. Turkel was one great fighter."

By Rep. John Zelinski: "I would also like to ask for a Moment of Silence for Mr. Post and Mrs. Wormser."

By Rep. Ellen Bromley: "A Moment of Silence and reflection for a little girl that died this week in New York who would not be famous but for the way she died and I think as legislators and leaders, we should all be cognizant of the abuses in this world and the programs we can support to help so those abuses don't happen."

By President Sandra Goldstein: "I join Claire Fishman in asking for a Moment of Silence for a person who I first met about 10 or 12 years ago who turned out to be one of the dearest, and most dynamic people I ever met in my life and this is Arthur Post. He touched everybody's life who knew him. His intelligence, his wit, his grasps of the issues, his understanding of people. He was a man to be adored and he was a man who adored people, especially politicans who he enjoyed every moment with. His interests spanned generations. He was a favorite of the young, his grandchildren, of his granchildren's friends, of his family's friends and of his own contemporaries.

Furthermore, he was a democrat with both a capital "D" and a small "d" and the principles of liberalism and democracy meant more to him than it meant to any human being that I've met. Those of us who knew him are poorer for having lost him. Those of you who never met him, are poorer for never having met him."

The Chair opened the Floor for nominations to replace Mr. Biancardi on the Board of Representatives.

Mr. Wider said that it has been a pleasure knowing Bobby Owens for 15 years. Mr. Owens has gained the respect of the 3rd District. Mr. Owens will give unselfishly of his time and Mr. Wider nominated Bobby Owens to replace Mr. Biancardi. The motion was Moved and Seconded.

President Goldstein called for a voice vote to approve Bobby Owens for the vacant seat in the 3rd District. APPROVED UNANIMOUSLY. President Goldstein administered the Oath of Office to Mr. Owens.
