Representative Cottrell read the following into the record:

Representatives:

The membership of the Cove Neighborhood Association has asked me to write to you as part of the Public Hearing comments involved in the Budget process. As many of you know the Cove Neighborhood envelops Cove Island Park, Cummings Park and West Beach. This includes Districts 1, 4 and 8.

Many of our residents in the Cove have fond feelings for these City Parks that in some cases have been formed over multiple generations.

It has become worrisome to many that this year's budget shows a cut to the Parks Police program and a request of \$300,000.00 for an Ambassador program. We remember when Parks Police were a regular presence in our parks and a feeling of safety greeted us upon our visits. Stamford may be considered a safe city by many standards, but safety is not only measured by crime report statistics. A feeling of safety is established by many small and difficult to measure indices. Needless to say, the primary source of this safe feeling is reinforced in the presence of a uniformed officer who understands what can and cannot be done in our Parks.

We really do not feel that an Ambassador can instill that same feeling since any serious matters they encounter could not be handled by them and they would simply be calling for a uniformed officer to deal with the problem.

For this reason, we respectfully request you eliminate the Mayor's request for the \$300,000.00 Ambassador Program.

There was continued discussion of this item. .

Representative Matherne read the following excerpt from a press release into the minutes:

On Thursday 04/26/18, the Stamford Police Department Patrol Division enacted a Quality of Life Enforcement detail at Lione Park. The purpose of the detail was to curb this concerning activity and to bring awareness to others that simple disorder in the park will not be tolerated. Within the 2 ½ hours that the detail was running the Officers issued 33 infraction summonses for offenses that dealt with the above behavior, 3 custodial drug arrests for sales and for interfering with the Police, 3 vehicles towed, a large amount of alcohol seized and a outdoor kitchen was dismantled. At the time of this operation there were approximately 100 persons loitering in the parking area of the park, all within close proximity of a youth soccer game occurring on the field.

Police Chief Jon Fontneau stated, "The Stamford Police Department is the primary crime fighting agency in the City of Stamford. We are confident that with a multifaceted approach and working with Parks and Recreation and other resources we will continue to address these types of concerns within our parks."

Types of tickets issued included numerous infractions for possession of marijuana, alcohol in glass containers, possession of hard alcohol, and infractions for creating a public disturbance (urination in public). Two arrests were made for drug transactions in and around the park.

Representative Matherne also read a letter from Officer Peter Gould:

I wanted to alert you to something.

I just saw a press release to The Advocate concerning a Quality of Life enforcement detail that happened last night at Lione Park. The press release talks about a major enforcement initiative that was undertaken in the park, with some drug deal arrests, traffic enforcement, and an unauthorized food sales as well as an alcohol sales operation that were both taken down.

What the press release doesn't mention is that I was ON this detail. In fact before it started, I provided a brief training session for the other officers on how to cite for violations of the park regulations. I was introduced to the group by Captain Hohn as "the guru of the park regulations."

When it came time to do the enforcement of the food sales operation and the alcohol sales operation, I did that part of the enforcement, I issued the summonses, I seized the evidence, and I wrote the police reports.

Yet in the press release, Chief Fontneau is quoted as saying “the Stamford Police Department is the primary crime fighting agency in Stamford” and Ted Jankowski is quoted as saying the Office of Public Safety and the Police Department were behind the operation – with ZERO mention that it was a mutual thing.

To be fair: while I handled the park regulation enforcement, city police handled the drug sales arrests, we both collaborated on traffic enforcement, and I did parking enforcement (including people who were parked in handicapped spaces). So it was absolutely mutual. I’m not saying I’m a hero or it was a one-person operation or anything like that. But there’s clearly an agenda to pretend this was 100% SPD with no park police involvement at all, and that’s simply false.

I’m concerned that some of your members may read the resulting article and be fooled.

Now, the Advocate reporters know what’s going on as well, and they may choose to ask some questions and not just print the press release.
