Mr. Morehardt reviewed the <u>attached presentation</u> with the Board. Board members discussed Item No. 1 with the invited guests. Items discussed included the following:

- There is a deadline of June 30th to submit the application to the State; then the timeline would be as follows: approval by the State by the end of the year; approval of the reimbursement rate of 60% from the General Assembly by June 30, 2024; engagement by the City of a design consultant (subject to approval by the BOF and BOR); and then construction contract. If all proceeds as scheduled, groundbreaking would be in December, 2025 or January, 2026.
- Tonight's approval is of the appropriation authority which is required to accompany the application to the State for this project.
- Both buildings would be fully accessible and have elevators.
- Sidewalk improvements would be offsite and ineligible for reimbursement; the current estimates relate to on-site work.
- Administrators might work at both sites, but no students would be going between sites during the day. There would be a school-based health clinic at the upper school, but lower school students would be brought there by their parents outside of school hours
- Improvements to sidewalks or streets would be a City initiative.
- The cost differences are due to square footage differences and completion date differences. There is a forecasted cost escalation for the upper school due to its later completion.
- The estimated costs include design and construction of both schools and the demolition of Toquam during the period 2024-2030.
- There will be additional middle school seats created by the building of the new Roxbury K-8 and additional seats at Westover, Hart, and Turn of River
- Two separate sites are needed because of space requirements; putting all students at one space would overwhelm the site
- The buildings would meet or exceed the State's minimum design standards of LEED Silver; each project contains an allotment for solar panels, geothermal heating and cooling, and meeting SSIC security guidelines.
- Lockwood currently houses CLC and DOMUS which will be leaving the site; the current 500 KT Murphy students will go to Lockwood
- The number of visitor spaces is in keeping with school design standards; events such as open houses would be broken up over several nights in order to accommodate space limitations as is currently done at other schools.

• There will be outreach to the community in the design phase.
