Mr. Cava explained that this is a settlement between the City and the Stamford Police Association for a 4 year contract, retroactive to July 1, 2022. The key terms are as follows:

Finance 6-0-0

- Wage increases of 2.85% for July 1, 2022, and 3.175% for July 1, 2023, 2024, and 2025.
- The Employee Medical Cost Share will increase ½ % to 13.5% effective January 1, 2024, ½ % to 14% effective July 1, 2023, and ½ % to 14.5% effective January 1, 2026
- A retiree with medical will only be able to opt out one time, as opposed to the current unlimited ability to opt in or opt out.
- A maximum will be placed on an officer's ability to earn compensatory time of 240 hours in any fiscal year; officers will be able to cash out some of their comp time and defer it into their 457; the goal of this change is to have employees work more often rather than take the time off
- Currently there are 125 officers with disability pensions and only 48 with regular service retirement; this puts a big strain on the pension fund; one priority was to correct that and eliminate the 30% rating requirement and replace it with a more traditional definition of disability. In exchange a COLA provision was added: Officers who retire effective November 1, 2023 shall be eligible to receive a 1% COLA increase each July 1. Only officers with a minimum of 20 years of service are eligible and it kicks in at age 65.
- The emergency sick leave bank was modified to include employees who are disabled due to pregnancy
- Two new ranks were recognized master police officer, entitling an officer to a 2.75% non-pensionable payment, and detective, entitling an officer to a 5% non-pensionable payment

Committee members discussed the proposed agreement with the invited guests. Items discussed included the following:

 The Board of Finance gave a negative advisory opinion because of concerns about the COLA being a new item which would harm the City in the future; COLA's have existed in the past, but infrequently and were complicated; this would be more routine

Mr. Cava explained that this is a settlement between the City and the Stamford Professional Firefighters' Association for a 6 year contract, retroactive to July 1, 2019. The key terms are as follows:

- Wages increases of 0.5% for July 1, 2019, 1.25% for January 1, 2020, 2.5% for July 1, 2020 and 2021, 3% for July 1, 2022, 3.125%, for July 1, 2023 and 2024
- The retiree medical premium cost share for firefighters hired after July 1, 2016, was changed to a flat 33.33% contribution, replacing the sliding scale based on years of service; officers' ability to perform decreases with age
- Active Medical Insurance (i) Effective July 1, 2023, an increase of 1% to 12% and effective July 1, 2024, an increase of 1% to 13%; (ii) Employees shall migrate to the State Partnership Plan effective January 1, 2024 (resulting in FY23-24 \$802,728 in premium savings, \$416,000 City HSA Contribution savings; total savings \$1,218,728; FY24-25 \$1,589,361 in premium savings, \$416,000 City HSA Contribution savings; total savings \$2,005,361).
- Effective July 1, 2024, increase the number of Deputy Chiefs on duty from one to two including Deputy Chief Aides (FY24-25 cost \$1,122,094).
- Remove the position of Fire Marshal from the bargaining unit to the pay plan.
- Provide for salary parity for the Assistant Fire Marshal with the Deputy Fire Chiefs (FY23-24 cost \$10,259, FY24-25 cost \$21,139).

A letter from Mr. Paul Anderson, the president of the Stamford Professional Firefighters' Association, was read into the record.

Committee members discussed the proposed agreement with the invited guests. Items discussed included the following:

- The Fire Marshal's office is a significant department within the fire service; someone
  outside of the bargaining unit will be in a better position to manage the department
- The deputy chief is the commander of any fire ground operation; other cities in CT with over 100,000 population have 2 or 3 incident commanders per shift; Stamford has only 1. The other cities are about 20 square miles; Stamford, including the water is about 50 square miles
- A second deputy chief and the chief's aide is being added for each of the 4 shifts
- Mr. Barnes stated that there will be a higher draw from fund balance for retroactive years for the contract than was planned; a few \$100,000 will have to be appropriated from contingency to fund balance and close to \$1,000,000 in fund balance for the retroactive years; this is relatively close to the amount in the original budget;
