**Subject:** Update on the City's Safe Debt Limit FY 14-15

**Date:** March 30th, 2015

The Board of Finance has requested a monthly update on the City's Safe Debt Limit for Fiscal Year 2014-2015. What follows is a listing of all of the supplemental capital appropriations approved by the Board of Finance and Representatives as of March 30th and the sources of funding used to finance those projects.
