## RESOLUTION NO. 3446 RENAMING SOUTHFIELD PARK AFTER THE LATE JOHN J. BOCCUZZI IN CONFORMANCE WITH SECTION 21 OF THE CODE OF ORDINANCES

**WHEREAS**, pursuant to Section 21-1 of the Code of Ordinances, a request to rename Southfield Park in memory of the late John J. Boccuzzi was submitted to the Board of Representatives; and

**WHEREAS**, Section 21-3B of the Code of Ordinances provides that a park or facility may be named to memorialize any person, inter alia, who has been deceased for more than six months prior to the request and contributed substantially to the establishment of such park or facilities or due to such person's contribution to the entire community; and

**WHEREAS**, Section 21-3B of the Code of Ordinance provides that upon a showing of good cause, the Board of Representatives may waive any of the aforementioned requirements by a resolution of 2/3 of the entire Board; and

**WHEREAS**, on September 6, 2011, the Board of Representatives waived the requirement that Southfield Park be named to memorialize a person who has been deceased for more than six months by a resolution of 2/3 of the entire Board; and

**WHEREAS**, the late 2<sup>nd</sup> District Representative John J. Boccuzzi was a life-long resident of Stamford until his death in April of 2011; and served as Majority Leader of the Board of Representatives for thirty-one years; and

**WHEREAS**, the late John J. Boccuzzi was the recipient of two Bronze Stars and one Purple Heart for his service in the U.S. Army from 1943-1945; and

**WHEREAS**, the late John J. Boccuzzi was a member of the Waterside Coalition, a member of St. Clement's Church Parish Council and Advisory Board and the former President of Ryle and Cloonan Schools PTO.

**NOW THEREFORE BE IT RESOLVED BY THE 28<sup>TH</sup> BOARD OF REPRESENTATIVES THAT**

Southfield Park is renamed John J. Boccuzzi Park.

This resolution shall take effect upon its adoption.


