THE PRESIDENT called upon the Chairman of the Legislative & Rules Committee, John T. D. Rich, to present the various Collective Bargaining Agreements for action.

AGREEMENT by and between THE CITY OF STAMFORD and the STAMFORD BOARD OF EDUCATION, and THE AMERICAN FEDERATION OF STATE, COUNTY AND MUNICIPAL EMPLOYEES, LOCAL 1083, AFL-CIO and COUNCIL 4 (To and including June 30, 1968)

MR. RICH MOVED for approval of the above named Collective Bargaining Agreement. Seconded by Mr. Kelly.

MR. NATHANSON rose on a point of information. He asked if the members of this Board, who are also school teachers, would be directly affected by this Agreement and if so, would it be proper for them to vote on it.

MR. RICH said the contract does not affect the school teachers.

MR. BITETTO MOVED THE QUESTION.

VOTE taken on Mr. Rich's motion. CARRIED unanimously.

AGREEMENT by and between THE CITY OF STAMFORD and LOCAL 786, INTERNATIONAL ASSOCIATION OF FIRE FIGHTERS (In force to and including June 30, 1968)

MR. RICH MOVED for approval of the above named Collective Bargaining Agreement. Seconded by Mr. Kelly, Mr. Bitetto and Mr. Chirimbes. CARRIED unanimously.

AGREEMENT by and between THE CITY OF STAMFORD and the STAMFORD POLICE ASSOCIATION (In force to and including June 30, 1968)

MR. RICH MOVED for approval of the above named Collective Bargaining Agreement. Seconded by Mr. Kelly, Mr. Bitetto and Mr. Chirimbes. CARRIED unanimously.

AGREEMENT by and between THE CITY OF STAMFORD and the TEAMSTERS LOCAL UNION 145 (In force to and including June 30, 1968, with provisions for automatic renewal, commencing with January 2, 1968)

MR. RICH MOVED for approval of the above named Collective Bargaining Agreement. Seconded by Mr. Kelly, Mr. Bitetto and Mr. Chirimbes. CARRIED unanimously.

ADJOURNMENT:

There being no further business to come before the Board, the meeting was adjourned at 9:10 P.M., on motion, duly seconded and CARRIED.
